This agreement is executed by the authorized representative of the respective organization and shall serve to bind all persons associated with the aforementioned parade unit. It shall be the responsibility of the undersigned to inform all persons associated with said unit as to the terms of this agreement including the liability and all matters relating to conduct during the parade. Failure to adhere to this agreement, the Parade Rules and Regulations, or the direction of parade personnel may result in immediate and/or future removal from the St. Patrick's Day Parade.
